Minutes

Financial Report

There was \$436,000 in the ING account, as of today there is \$30,000 in the TD account, just waiting on a deposit of rep fees later this week. There is an ice bill of \$92,000 that needs to be paid. Steve Sumka asked Terri Kent what the \$100 on the income statement for trophies and awards for. Terri said it was for gift cards given to MC on the day of champs. Motion to accept financial report, Craig Barnacal 1st the motion, Marie Feeney 2nd the motion, all in favour, motion carried.

House League Tournament

The registration so far is lower than last year. There are a lot of Minor Midget teams from Guelph registered. The directors should encourage our teams to participate. Rick Stevens suggested in the

future to eliminate minor major teams. The deadline for registration is November 28.

Committee Reports

The coach selection committee so far only has 5 people but it has been viewed 2700 times. The risk management team would be willing to help source the material of questions to ask. Rick suggested to pick the coaches earlier then post it on the website. Craig Barnacal think OMH should bring OMHA and pay them to pick the teams. Steve Sumka stated that he has no problem putting these committees together but he needs help, Craig Barnacal said he would help. The coach development session this last Saturday had 16 registered and 12 showed up, this was open to everyone. The feedback was very positive. Craig Barnacal thinks that if Rep coaches don't want attend this then they should send their assistant coach. There will be 2 more coach development days. Rick Stevens think that if there is not enough our coaches attending then open it up to the girls hockey coaches to attend. The player development committee will be getting off the ground soon. The November 2 goalie clinic was a great success, Steve Sumka feels 2 hours is too long, 1 hour 20 minutes is good.

Sponsors
